By clicking "I Agree" during registration, you ("User") accept these Conditions, which supplement the Platform Terms of Service. These Conditions ensure compliance with MiCA (Regulation (EU) 2023/1114), GDPR, and Czech law.

### 1. ABOUT THE MARKETPLACE

The Marketplace allows you to browse tokenized projects offering MiCA-compliant Other Crypto-Asset (OCA) tokens. Viewing full project details or purchasing tokens requires registration and, in some cases, KYC/KYB verification via ComplyCube. ### 2. YOUR ACCESS

Browsing: You can view limited project details (e.g., title, summary) without registering. Full details (e.g., tokenomics, white papers) require registration.

Registration: Sign in via Google, Apple, or email to access the full Marketplace, agreeing to these Conditions.

Restrictions: We may limit access if you violate these Conditions or fail KYC/KYB checks.

### 3. YOUR RESPONSIBILITIES

Accurate Data: Provide truthful information (e.g., email) during registration, per GDPR and MiCA requirements.

Proper Use: Don't misuse the Marketplace (e.g., scraping data, attempting unauthorized access).

Pre-Purchase: Browsing projects is not a purchase commitment. Buying tokens requires signing the Token Buyer Agreement and completing KYC/KYB.
